I. REVIEW OF PREVIOUS MEETING MINUTES

Vote was UNANIMOUS, 3–0 to approve.

2) Training Advisory Panel:

Vice Chair Fritz SECONDED the MOTION. Vote was UNANIMOU; <u>3-0 in favor</u>. The Chair stated that he will add the policy to the Commission's webpage.

5) Probationary Pilot License Status:

Chair McVay advised that Capt. Harper's probationary license expires December 27, 2019 and would need an extension to continue piloting. Commissioner Hoxsie made a

III. NEW BUSINESS

State Pilot Board Review and Changes:

Chair McVay advised that Capt. Bogus and Capt. Gray sent the Commission their requests to serve on the State Pilot Board. The members agreed to appoint Capt. Gray and Capt. Bogus to the Board. Chair McVay made a MOTION to remove Capt. Astles and Capt. Kirby from the State Pilot Board. Vice Chair Fritz SECONDED the MOTION. Vote was UNANIMOUS. 3-0 in favor.

Chair McVay made another MOTION to appoint both Capt. Gray and Capt. Bogus to serve on the State Pilot Board. Vice Chari Fritz SECONDED the MOTION. Vote was UNANIMOUS. 3-0 in favor.

IV. OTHER BUSINESS

Pilot Training:

Vice Chair Fritz distributed "Draft" training classes for apprentice, probationary, and full-branch pilots for discussion. Commissioners and pilots discussed training that will be mandated per regulations. Chair McVay stated he will edit Vice Chair's draft to include proposals and other revisions made at December's meeting. The revised list will include course, length of course, frequency, and required refreshers. Once the commission approves the courses, commission's counsel will draft regulations for ORR's review/approval. Vice Chair entertained a MOTION for Chair McVay to revise draft training courses to be presented at the January meeting for final approval. Chair McVay SECONDED the MOTION. 3-0 in favor.

Vice Chair Fritz was excused from the remainder of the meeting at approximately 11:00am.
