NOTICE OF VIOLATION

A. Introduction

Pursuant to Sections 42-17.1-2(21) and 42-17.6-3 of the Rhode Island General Laws, as amended, (“R.I. Gen. Laws”) you are hereby notified that the Director of the Department of Environmental Management (the “Director” of “DEM”) has reasonable grounds to believe that the above-named party (“Respondent”) has violated certain statutes and/or administrative regulations under DEM's jurisdiction.

B. Administrative History

On February 22, 2011, DEM issued a written informal notice to Respondent regarding the property that is the subject of this Notice of Violation (“NOV”). The informal notice advised Respondent that, in accordance with the Rhode Island Cesspool Act, if the property has a cesspool and is in an area subject to the Act, Respondent must connect the plumbing for the dwelling on the property to public sewers by January 1, 2014 or, if public sewers are not available, apply to DEM for a new onsite wastewater treatment system (“OWTS”) and install the system within 1 year of DEM’s approval. On August 23, 2011, DEM received a form signed by Respondent. Respondent acknowledged that the property has a cesspool and is in an area subject to the Act. On April 4, 2014, DEM issued an Expedited Citation Notice (“ECN”) to Respondent that included an administrative penalty of \$200. The ECN required Respondent to connect the plumbing for the dwelling on the property to public sewers within 30 days or, if public sewers are not available, apply to DEM for a new onsite wastewater treatment system (“OWTS”) within 30 days and install the system within 14 days of DEM’s approval. On July 17, 2018, DEM approved an application submitted by Respondent to construct a new OWTS. Respondent failed to construct the OWTS, and DEM’s approval expired on July 17, 2019. As of the date of the NOV, Respondent has not complied with the ECN.

C. Facts

- (1) The property is located at 136 Congdon Avenue, Assessor’s Plat 68, Lot 68 in the Town of North Kingstown, Rhode Island (the “Property”). The Property includes a residential dwelling (the “Dwelling”)
- (2) Respondent owns the Property.

- (3) On August 23, 2011, DEM received a written certification from Respondent that the Property has a cesspool that is located within 200 feet of the inland edge of a shoreline bordering a tidal water area (corresponding to the jurisdiction of the Rhode Island Coastal Resources Management Council).
- (4) On July 17, 2018, DEM approved an application submitted by Respondent (the “Approval”) to replace the cesspool on the Property with a new onsite wastewater treatment system (“OWTS”).
- (5) On July 17, 2019, the Approval expired.
- (6) As of the date of this Notice of Violation (“NOV”), Respondent has failed to construct the OWTS or renew the Approval.

D. Violation

Based on the foregoing facts, the Director has reasonable grounds to believe that you have violated the following statutes and/or regulations:

- (1) **R.I. Gen. Laws Section 23-19.15-6(b)(3)** – prohibiting the use of cesspools and requiring the proper abandonment of cesspools located within 200 feet of the inland edge of a shoreline bordering a tidal water area (corresponding to the jurisdiction of the Rhode Island Coastal Resources Management Council) by January 1, 2014.
- (2) ***Rules Establishing Minimum Standards Relating to Location, Design, Construction and Maintenance of Onsite Wastewater Treatment Systems, Rule 53.3.3 [effective July 9, 2012 through July 16, 2014]*** – requiring the proper abandonment of cesspools located within 200 feet of the inland edge of a shoreline bordering a tidal water area (corresponding to the jurisdiction of the Rhode Island Coastal Resources Management Council) by January 1, 2014.
- (3) ***Rules Establishing Minimum Standards Relating to Location, Design, Construction and Maintenance of Onsite Wastewater Treatment Systems, Rule 53.3.3 [effective July 16, 2014 through June 27, 2016]*** – requiring the proper abandonment of cesspools located within 200 feet of the inland edge of a shoreline bordering a tidal water area (corresponding to the jurisdiction of the Rhode Island Coastal Resources Management Council) by January 1, 2014.
- (4) ***Rules Establishing Minimum Standards Relating to Location, Design, Construction and Maintenance of Onsite Wastewater Treatment Systems, Rule 53.3.3 [effective June 27, 2016 through November 25, 2018]*** – requiring the proper abandonment of cesspools located within 200 feet of the inland edge of a shoreline bordering a tidal water area (corresponding to the jurisdiction of the Rhode Island Coastal Resources Management Council) by January 1, 2014.

- (5) **Rhode Island Code of Regulations titled *Rules Establishing Minimum Standards Relating to Location, Design, Construction and Maintenance of Onsite Wastewater Treatment Systems (250-RICR-150-10-6)* [effective November 25, 2018 to Current] (the “OWTS Regulations”), Part 6.57(C)(3)** – requiring the proper abandonment of cesspools located within 200 feet of the inland edge of a shoreline bordering a tidal water area (corresponding to the jurisdiction of the Rhode Island Coastal Resources Management Council) by January 1, 2014.

E. Order

Based upon the violations alleged above and pursuant to R.I. Gen. Laws Section 42-17.1-2(21), you are hereby ORDERED to:

- (1) **IMMEDIATELY** cease use of the cesspool.
- (2) **Within 30 days of receipt of the NOV**, apply to DEM’s Office of Water Resources to renew the Approval (the “Application”).
- (3) The Application shall be subject to DEM’s review and approval. Upon review, DEM shall provide written notification to you either granting formal approval or stating the deficiencies therein. Within 7 days (unless a longer time is specified) of receiving a notification of deficiencies in the Application, you must submit to DEM a modified proposal or additional information necessary to correct the deficiencies.
- (4) **Within 14 days of DEM’s approval of the Application**, complete all work in accordance with the approval as evidenced by the issuance of a Certificate of Conformance by DEM.

F. Penalty

- (1) Pursuant to R.I. Gen. Laws Section 42-17.6-2, the following administrative penalty, as more specifically described in the attached penalty summary and worksheets, is hereby ASSESSED, jointly and severally, against each named respondent:

**\$6,000**

- (2) The proposed administrative penalty is calculated pursuant to the Rhode Island Code of Regulations titled *Rules and Regulations for Assessment of Administrative Penalties (250-RICR-130-00-1)* and must be paid to DEM within 30 days of your receipt of the NOV. Payment shall be in the form of a certified check, cashier’s check or money order made payable to the “General Treasury - Water & Air Protection Program” and shall be forwarded to DEM’s Office of Compliance and Inspection, 235 Promenade Street, Suite 220, Providence, Rhode Island 02908-5767.

- (3) Penalties assessed against Respondent in the NOV are penalties payable to and for the benefit of the State of Rhode Island and are not compensation for actual pecuniary loss.
- (4) If any violation alleged herein shall continue, then each day during which the violation occurs or continues shall constitute a separate offense and the penalties and/or costs for that violation shall continue to accrue in the manner set forth in the attached penalty summary and worksheets. The accrual of additional penalties and costs shall be suspended if DEM determines that reasonable efforts have been made to comply promptly with the NOV.

G. Right to Administrative Hearing

- (1) Pursuant to R.I. Gen. Laws Chapters 42-17.1, 42-17.6, 42-17.7 and 42-35, each named respondent is entitled to request a hearing before DEM's Administrative Adjudication Division regarding the allegations, orders and/or penalties set forth in Sections B through F above. All requests for hearing MUST:
  - (a) Be in writing. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.6-4(b);
  - (b) Be **RECEIVED** by DEM's Administrative Adjudication Division, at the following address, within 20 days of your receipt of the NOV. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.7-9:

  - (c) Indicate whether you deny the alleged violations and/or whether you believe that the administrative penalty is excessive. See R.I. Gen. Laws Section 42-17.6-4(b); **AND**
  - (d) State clearly and concisely the specific issues which are in dispute, the facts in support thereof and the relief sought or involved, if any. See Part 1.7(B) of the Rhode Island Code of Regulations titled *Rules and Regulations for the Administrative Adjudication Division (250-RICR-10-00-1)*.

- (3) Each named respondent has the right to be represented by legal counsel at all administrative proceedings relating to this matter.
- (4) Each respondent must file a separate and timely request for an administrative hearing before DEM's Administrative Adjudication Division as to each violation alleged in the written NOV. If any respondent fails to request a hearing in the above-described time or manner regarding any violation set forth herein, then the NOV shall automatically become a Final Compliance Order enforceable in Superior Court as to that respondent and/or violation and any associated administrative penalty proposed in the NOV shall be final as to that respondent. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and (vi) and 42-17.6-4(b) and (c).
- (5) Failure to comply with the NOV may subject each respondent to additional civil and/or criminal penalties.
- (6) An original signed copy of the NOV is being forwarded to the Town of North Kingstown, Rhode Island wherein the Property is located to be recorded in the Office of Land Evidence Records pursuant to R.I. Gen. Laws Chapter 34-13 and Section 42-17.1-2(13), as amended.
- (7) The NOV does not preclude DEM from taking any additional enforcement action nor does it preclude any other local, state, or federal governmental entities from initiating enforcement actions based on the acts or omissions described herein.
