NOTICE OF VIOLATION

A. Introduction

Pursuant to Sections 42-17.1-2(21) and 42-17.6-3 of the Rhode Island General Laws, as amended, ("R.I. Gen. Laws") you are hereby notified that the Director of the Department of Environmental Management (the "Director" of "DEM") has reasonable grounds to believe that the above-named party ("Respondent") has violated certain statutes and/or administrative regulations under DEM's jurisdiction.

B. Facts

- (1) The subject property is a dam identified as Quidnick Reservoir Dam, State Identification Number 175, located approximately 5,000 feet northeast of the intersection of Harkney Hill Road and Victory Highway, approximately 100 feet south of Harkney Hill Road, in the town of Coventry, Rhode Island ("Dam 175").
- (2) The Respondent owns Dam 175.
- (3) Dam 175 is classified by DEM as Significant Hazard.
- (4) On July 13, 2012 Dam 175 was inspected. The inspection revealed the following:
  - (a) Vegetation in the following areas did not allow a proper inspection to be performed:
    - (i) Along the downstream side of the crest between the chain link fence and the top of the downstream wall;
    - (ii) The downstream side of the embankment along the wall;
    - (iii) The downstream side of the embankment along the toe;
    - (iv) The right five (5) to ten (10) feet of the primary spillway;
  - (b) The crest in the area adjacent to the left side of the primary spillway is about one (1) foot lower than the rest of the crest and reportedly overtopped in 2010; and

- (c) Numerous large stones and other debris are present in the low level outlet channel that may affect the discharge capacity of the outlet.
- (5) DEM considers Dam 175 unsafe for the following reasons:
  - (a) Vegetation that inhibits a proper inspection;
  - (b) A lowered section of the crest; and
  - (c) Debris in the low level outlet channel.

C. Violation

Based on the foregoing facts, the Director has reasonable grounds to believe that you have violated the following statutes and/or regulations:

- (1) **DEM's Rules and Regulations for Dam Safety (the "Dam Safety Regulations"), Rule 4A** – requiring the owner of a significant hazard dam to maintain the dam in a safe condition.

D. Order

Based upon the violations alleged above and pursuant to R.I. Gen. Laws Section 42-17.1-2(21), you are hereby ORDERED to:

- (1) **Within ninety (90) days of receipt of the Notice of Violation ("NOV")**, cut or remove the vegetation from the areas of Dam 175 as described in Section B.4.a above in accordance with the DEM's Dam Safety Regulations, Rule 10A. Cutting or removal shall be in sufficient amounts to allow a thorough visual inspection to be performed. DEM shall be notified upon commencement and completion of this work.
- (2) **Within ninety (90) days of receipt of the NOV**, remove all stones and debris from the low level outlet that could obstruct flow. DEM shall be notified upon commencement and completion of this work.
- (3) **Within one hundred eighty (180) days of receipt of the NOV**, retain a professional engineer fully registered in the State of Rhode Island, who is experienced with dam inspections, and have the engineer complete a visual inspection of Dam 175 in accordance with the DEM's Dam Safety Regulations, Rule 11C and submit a report of the inspection findings to DEM. The inspection must include an evaluation of the lowered section of the crest. The report must specify any actions necessary to return the dam to a safe condition and include a schedule to complete the work. For any proposed repairs to Dam 175, the report must include an application prepared in accordance with the DEM's Dam Safety Regulations, Rule 10B.

- (4) The report, application, and/or schedule required in Section D.3 above shall be subject to DEM review and approval. Upon review, the DEM shall provide written notification to the Respondent either granting formal approval or stating the deficiencies therein. **Within fourteen (14) days (unless a longer time is specified) of receiving a notification of deficiencies**, the Respondent shall submit to the DEM a modified report, application, and/or schedule or additional information necessary to correct the deficiencies.
- (5) Commence work specified in the schedule approved by the DEM within twenty (20) days of approval (unless otherwise expressly authorized by the DEM in writing to commence work at a later time), and complete such work in accordance with the approved schedule.

E. Right to Administrative Hearing

- (1) Pursuant to R.I. Gen. Laws Chapters 42-17.1, 42-17.6, 42-17.7 and 42-35, each named respondent is entitled to request a hearing before the DEM Administrative Adjudication Division regarding the allegations and/or orders set forth in Sections B through D above. All requests for hearing **MUST**:
  - (a) Be in writing. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.6-4(b);
  - (b) Be **RECEIVED** by DEM's Administrative Adjudication Division, at the following address, within twenty (20) days of your receipt of this NOV. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.7-9:

  - (c) Indicate whether you deny the alleged violations. See R.I. Gen. Laws Section 42-17.6-4(b); **AND**
  - (d) State clearly and concisely the specific issues which are in dispute, the facts in support thereof and the relief sought or involved, if any. See Rule 7.00(b) of the DEM Administrative Rules of Practice and Procedure for the Administrative Adjudication Division of Environmental Matters.

- (3) Each named respondent has the right to be represented by legal counsel at all administrative proceedings relating to this matter.
- (4) Each respondent must file a separate and timely request for an administrative hearing before DEM's Administrative Adjudication Division as to each violation alleged in the written NOV. If any respondent fails to request a hearing in the above-described time or manner with regard to any violation set forth herein, then this NOV shall automatically become a Final Compliance Order enforceable in Superior Court as to that respondent and/or violation. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and (v) and 42-17.6-4(b) and (c).
- (5) An original signed copy of this NOV is being forwarded to the town of Coventry wherein the Property is located to be recorded in the Office of Land Evidence Records pursuant to R.I. Gen. Laws Chapter 34-13 and Section 46-19-4(c), as amended
- (6) This NOV does not preclude the Director from taking any additional enforcement action nor does it preclude any other local, state, or federal governmental entities from initiating enforcement actions based on the acts or omissions described herein.
