## **MODIFIED FINAL AGENCY ORDER**

A Decision and Order of Remand ("Remand") dated October 3, 2001 was issued by the Director in this matter. The Remand adopted the Recommended Decision and Order dated August 7, 2001 but modified it in part concerning suspension of the Respondent's licenses. An Order was issued on October 5, 2001<sup>1</sup> which afforded Respondent until October 19, 2001 to file a written proposed schedule for the implementation of the license suspensions. The Division was allowed until October 26, 2001 to file a response. As of the date of this Order, Respondent has not filed a proposed schedule with AAD. The Division did timely file a Proposed Suspension Schedule for consideration.

Wherefore, based on the foregoing and in accordance with the Remand, it is hereby

## **ORDERED**

- 1. The fifteen (15) day suspension of the Respondent's Multi-Purpose Dealer's License and Special Permit for Aquaculture is imposed for the following periods:
  - (a) commencing at 12:01 a.m. on Monday, November 26, 2001 through 11:59 p.m. on Friday, November 30, 2001.
  - (b) commencing at 12:01 a.m. on Monday, December 3, 2001 through 11:59 p.m. on Friday, December 7, 2001.
  - (c) commencing at 12:01 a.m. on Monday, December 10, 2001 through 11:59 p.m. on Friday, December 14, 2001.

Provided however that during the above proposed suspension period the Respondent is permitted to maintain the Respondent's cultured species. Maintenance, however, does not extend to the marketing of cultured or harvested species to consumers or wholesalers, either directly or indirectly, nor the purchasing of cultured or harvested species.
