FINAL ORDER OF DEFAULT

This matter came before the Hearing Officer for a status conference on May 4, 2001. Respondent failed to comply with the Status Conference Order or otherwise apprise the Hearing Officer or opposing counsel of its inability to appear to said status conference. On May 9, 2001, this Hearing Officer issued a Conditional Order of Default affording Respondent until May 17, 2001 to show good cause in writing why a Final Order of Default should not enter and the Notice of Violation become a Compliance Order. Respondent's President responded in writing that due to employment obligations he was unable to appear. He requested that the status conference be rescheduled late in the day to accommodate his work schedule. Counsel for OCI objected to vacating the Conditional Order of Default. On June 25, 2001 an Order was issued rescheduling the status conference to July 9, 2001 at 3:30 p.m. The Order kept the Conditional Order of Default in effect and advised that a failure to appear would result in issuance of a Final Order of Default. Respondent failed to comply with that Order and again failed to apprise the Hearing Officer or opposing counsel of his inability to appear for the rescheduled status conference. Attempts to reach Respondent's President at the place of business and at his residence were unsuccessful.
