## ORDER OF DISMISSAL

This matter is before the hearing officer on the Motion to Dismiss filed by the Division of Groundwater and ISDS on March 31, 1993. The Motion asserts that Respondent's request for hearing was untimely, and accordingly, the Administrative Adjudication Division for Environmental Matters ("AAD") lacks jurisdiction to entertain the appeal.

In support of its Motion, the Division has supplied a copy of the return receipt card indicating that Respondent received the Notice of Violation ("NOV") on February 20, 1993. The request for hearing was filed with the Clerk on March 8, 1993, sixteen (16) days after receipt of the NOV.

The AAD and the Director have consistently ruled in prior matters that the ten-day appeal requirement is absent a timely jurisdictional and filing, AAD lacks jurisdiction to entertain the appeal. See, Abate and Ursillo Plating Co., et al, AAD No. 91-011/AHE and Cumberland Park Homes, Inc., AAD No. 91-017/FWA. Moreover, in the instant matter, Respondent has filed no objection to the Division's Procedurally, Respondent's objection is deemed Motion. waived pursuant to Rule 8.00 a).2 of the Division's 041393
