FINAL ORDER OF DEFAULT

This matter came before Hearing Officer Mary F. McMahon for consideration of the Motion to Enter Conditional Order of Default filed by the Office of Compliance and Inspection ("OCI") on October 8, 1998. Respondent did not file any objection. On October 29, 1998, a Conditional Order of Default was entered which ordered Respondent to show good cause why a default judgment should not enter and the Notice of Violation become a compliance order. Respondent was given until November 5, 1998 to make his showing. As of this date Respondent has not responded to either OCI's motion or to the conditional order.

A review of the record reveals that Respondent was required by order dated September 8, 1998 to attend the prehearing conference on October 1, 1998 and was required to provide the Administrative Adjudication Division with a copy of his doctor's certificate verifying the nature and duration of his incapacity, an incapacity that was the reason for the previous continuance of the prehearing

conference which had been scheduled for September 4, 1998. By conference call on October 1, 1998, Respondent represented that he had an appointment with his doctor on October 1, 1998 and would either have the doctor transmit the note by facsimile transmission or he would do so. The transmission was to be sent to the Administrative Adjudication Division and to OCI's counsel on or before

October 2, 1998. This Hearing Officer advised Respondent that the prehearing conference was continued subject to the transmission and to a conference call with the parties on October 5, 1998, following the OCI's opportunity to review the doctor's communication.

Respondent failed to transmit such certification from his doctor and failed to conference call on October 5, 1998 with the OCI's counsel and Hearing Officer as he had been ordered. Respondent failed to comply with a condition for the continuance of the scheduled prehearing conference. Further, Respondent has not objected to the OCI's motion for default and has not responded to the Conditional Order of Default.

Wherefore, in consideration thereof, it is hereby

ORDERED

Respondent is deemed to have waived his right to an adjudicatory hearing and the Notice of Violation issued on February 10, 1998 shall be final and become a compliance order immediately upon the entry of the Final Agency Order herein. **EARMINE J. GALLUCCI** AAD No. 98-002/FWE Page *3*
