#### FINAL ORDER OF DEFAULT

This matter came on before Hearing Officer David Kerins on August 17, 2017 for entry of a Final Judgment of Default. On July 10, 2017 an Order was issued scheduling an Administrative Hearing for July 25, 2017 at 9:30 a.m. The Respondent, Richard Fenner, advised in an e-mail dated July 17, 2017 that he would not be in attendance at the Hearing (see OC&I Exhibit A). Respondents failed to appear on the Hearing date. On July 27, 2017 the OC&I filed a Motion for Entry of Final Judgment. As of August 17, 2017 no Objection or response has been received from Respondent.

#### FINDING OF FACT

- On May 17, 2017 a Prehearing Conference Record and Order was issued setting the matter down for Administrative Hearing on July 18, 2017 at 9:30 a.m.
- 2. The Prehearing Conference Record and Order stated that a Final Judgment would be entered for non-appearance.
- On July 17, 2017 the Respondent, Richard Fenner, sent an e-mail to the AAD Clerk advising that he would not attend the Administrative Hearing.
- 4. Respondents failed to appear for the Administrative Hearing on July 25, 2017.
- 5. On July 27, 2017 the OC&I filed a Motion for Entry of Final Judgment of Default.
- 6. As of August 17, 2017 no Objection or response has been received from the Respondents.
- 7. Respondents are in Default.
