# **NOTICE OF VIOLATION**

#### A. <u>INTRODUCTION</u>

Pursuant to Sections 42-17.1-2(21) and 42-17.6-3 of the Rhode Island General Laws, as amended, ("R.I. Gen. Laws") you are hereby notified that the Director of the Rhode Island Department of Environmental Management ("Director" of "RIDEM") has reasonable grounds to believe that the above-named party ("Respondent") has violated certain statutes and/or administrative regulations under RIDEM's jurisdiction.

- B. <u>FACTS</u>
  - (1) The property includes a dam identified as Hawkins Pond Dam, State Identification Number 555, located approximately 2,000 feet west of the intersection of Pulaski Road and Putnam Pike, approximately 470 feet north of Putnam Pike, Assessor's Plat 1, Lot 32 in Glocester, Rhode Island ("Dam 555").
  - (2) Respondent owns Dam 555.
  - (3) Dam 555 is classified by RIDEM as High Hazard.
  - (4) On 6 October 2022, Dam 555 was inspected. The inspection revealed that the spillway training walls were undermined resulting in erosion of the adjacent embankment.
  - (5) RIDEM considers Dam 555 unsafe because of the findings described in subsection B (4) above.

#### C. <u>VIOLATION</u>

Based on the foregoing facts, the Director has reasonable grounds to believe that you have violated the following statutes and/or regulations:

(1) Rhode Island's *Rules and Regulations for Dam Safety* (250-RICR-130-05-1) ("DS Rules"), Part 1.6(A) – requiring the owner of a high hazard dam to maintain the dam in a safe condition.

# D. <u>ORDER</u>

Based upon the violations alleged above and pursuant to R.I. Gen. Laws Section 42-17.1-2(21), you are hereby ORDERED to:

- (1) Within 90 days of receipt of the NOV, retain a professional engineer fully registered in the State of Rhode Island, who is experienced with dam inspections, design, construction, and repair ("Dam Engineer").
- (2) Within 180 days of receipt of the NOV, the Dam Engineer must complete a visual inspection of the spillway training walls and submit a report of the inspection findings to RIDEM. The report must specify the actions necessary to return the spillway training walls to a safe condition and include a proposed schedule to complete the work. For any proposed repairs, the report must include an application prepared in accordance with the DS Rules, Part 1.10(B).
- (3) The report, application, and/or schedule required above shall be subject to RIDEM's review and approval. Upon review, RIDEM shall provide written notification to Respondent either granting formal approval or stating the deficiencies therein. Within 14 days (unless a longer time is specified) of receiving a notification of deficiencies, Respondent shall submit to RIDEM a modified report, application, and/or schedule or additional information necessary to correct the deficiencies.
- (4) Commence work specified in the schedule approved by RIDEM within 20 days of approval (unless otherwise expressly authorized by RIDEM in writing to commence work later) and complete such work in accordance with the approved schedule.

# E. <u>RIGHT TO ADMINISTRATIVE HEARING</u>

- Pursuant to R.I. Gen. Laws Chapters 42-17.1, 42-17.6, 42-17.7 and 42-35, each named respondent is entitled to request a hearing before RIDEM's Administrative Adjudication Division regarding the allegations and/or orders set forth in Sections B through D above. All requests for hearing MUST:
  - (a) Be in writing. <u>See</u> R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.6-4(b).
  - (b) Be **RECEIVED** by RIDEM's Administrative Adjudication Division, at the following address, within 20 days of your receipt of the NOV. <u>See</u> R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.7-9:

- (c) Indicate whether you deny the alleged violations. <u>See</u> R.I. Gen. Laws Section 42-17.6-4(b).
- (d) State clearly and concisely the specific issues which are in dispute, the facts in support thereof and the relief sought or involved, if any. <u>See</u> Part 1.7(B) of Rhode Island's *Rules and Regulations for the Administrative Adjudication Division* (250-RICR-10-00-1).
- (2) A copy of each request for hearing must also be forwarded to:

- (3) Each named respondent has the right to be represented by legal counsel at all administrative proceedings relating to this matter.
- (4) Each respondent must file a separate and timely request for an administrative hearing before RIDEM's Administrative Adjudication Division as to each violation alleged in the written NOV. If any respondent fails to request a hearing in the above-described time or manner regarding any violation set forth herein, then the NOV shall automatically become a Final Compliance Order enforceable in Superior Court as to that respondent and/or violation. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and (vi) and 42-17.6-4(b) and (c).
- (5) Failure to comply with the NOV may subject each respondent to additional civil and/or criminal penalties.
- (6) An original signed copy of the NOV is being forwarded to the Town of Glocester, Rhode Island wherein the Property is located to be recorded in the Office of Land Evidence Records pursuant to R.I. Gen. Laws Chapter 34-13 and Section 46-19-4(c), as amended.
- (7) The NOV does not preclude the Director from taking any additional enforcement action nor does it preclude any other local, state, or federal governmental entities from initiating enforcement actions based on the acts or omissions described herein.
