CONDITIONS

1. The Applicant will accept responsibility for any and all liabilities, which may result from and are connected with the installation, maintenance, and repairs to the sign(s) and will hold the State of Rhode Island Department of Transportation harmless, and will list said Department as additional insured on the Applicant's Liability Insurance Certificate in the amount of \$1,000,000 per-occurrence.
2. All sign(s) shall be fabricated, installed, and maintained by a licensed signed manufacturer.
3. All sign(s) will conform to public safety, specifications, and appearance as described in these conditions, standard sign design, mounting and location sheets as provided.
4. R.I.D.O.T. reserves the right to relocate or remove sign(s) at anytime without written approval from the Applicant.
5. At no time shall an Agricultural sign(s) be attached to, obstruct, or placed adjacent to more important highway signs.
6. Agricultural Directional signs shall not direct traffic away from another Agricultural Business selling the same product.
7. No more than 2 signs shall be installed in each direction for any one location.
8. If 2 signs are installed in advance of the Agricultural Business, the first sign in each direction shall display in the lower section of the sign the appropriate distance message in lieu of displaying the list of produce. The following legend shall be shown NEXT LEFT – NEXT RIGHT – AHEAD – 500 FT. At no time shall the first sign be installed at a distance to the Agricultural Business greater than 500 FT.
9. The second sign (closest to the entrance) may display a right or left arrow as deemed appropriate in lieu of displaying produce sold.
10. At no time shall additional private signs displaying products sold be placed adjacent to the roadway that may be visible to motorists when Agricultural Directional signs are in place.
11. At no time shall Agricultural signs display dollar amounts, sales, or products that are not grown on the premise of the Agricultural Business.
