# **CONSENT AGREEMENT**

### A. INTENT & PURPOSE

This Agreement is entered by and between the Rhode Island Department of Environmental Management ("RIDEM") Office of Compliance & Inspection and Alexander Perry, d/b/a Pyramid Painting (the "Respondent"). This Agreement is entered in accordance with Section 42-17.1-2 et seq. of the Rhode Island General Laws ("R.I. Gen. Laws") for the purpose of resolving the administrative enforcement action set forth in a Notice of Violation ("NOV") issued to the Respondent by RIDEM on 4 February 2011.

## B. STIPULATED FACTS

- (1) WHEREAS, the subject properties are located at 27 Cushing Street and 710 River Street both in the city of Providence, Rhode Island (the "Properties").
- (2) WHEREAS, the Respondent is a registered residential contractor subject to the RIDEM Air Pollution Control ("APC") Regulations doing business as Pyramid Painting and was directing work at the Properties.
- (3) WHEREAS, on 4 February 2011, RIDEM issued a NOV to the Respondent alleging certain violations of the APC Regulation No. 24.
- (4) WHEREAS, the Respondent failed to request an administrative hearing to contest the NOV.
- (5) WHEREAS, in lieu of proceeding to Superior Court to enforce the NOV and to effect a timely and amicable resolution of the NOV, RIDEM and the Respondent hereby agree that it is in the best interest of the parties and in the public interest to resolve the issues raised in the NOV.
- (6) WHEREAS, RIDEM finds that this Agreement is a reasonable and fair settlement and adequately protects the public interest in accordance with the APC Regulations.

### C. AGREEMENT

- (1) <u>JURISDICTION</u> RIDEM has jurisdiction over the subject matter of this Agreement and has personal jurisdiction over the Respondent.
- (2) <u>FORCE and EFFECT</u> This Agreement shall have the full force and effect of a final compliance order issued after a full hearing on the merits pursuant to the Administrative Procedures Act, R.I. Gen. Laws Section 42-35-1 et seq. from which no timely appeal was taken, and which is enforceable in Superior Court in accordance with R.I. Gen. Laws Section 42-17.1-2(21)(v).
- (3) <u>APPLICATION</u> The provisions of this Agreement shall apply to and be binding upon RIDEM, the Respondent and his agents, servants, employees, successors, assigns and all persons, firms and corporations acting under, through and for the Respondent in the performance of work relating to or impacting the requirements of this Agreement.

## (4) CONDITIONS –

- (a) Penalty The Respondent shall pay to RIDEM the sum of **Two Thousand Eight Hundred Seventy Five Dollars (\$ 2,875.00)** in administrative penalties assessed as follows:
  - (i) The Respondent shall pay to RIDEM the sum of **One Thousand Four Hundred Seventy Five Dollars (\$ 1,475.00) on or before 15 April 2011**.
  - (ii) The remainder of the penalty, **One Thousand Four Hundred Dollars** (\$ 1,400.00), shall be paid to RIDEM on or before 15 June 2011.
  - (iii)Penalties that the Respondent agrees to pay in this Agreement are penalties payable to and for the benefit of the State of Rhode Island and are not compensation for actual pecuniary loss.
  - (iv)In the event that the Respondent fails to remit to RIDEM a payment on or before its due date, that payment will be considered late and the Respondent will be in default. If the payment is not received within thirty (30) days of its due date, interest shall begin to accrue on the entire unpaid balance at the rate of twelve percent (12%) per annum. Interest will accrue at this rate beginning with the day after the due date specified in this Agreement until such date all past due installment payments and interest owed are remitted. Interest shall be calculated using the following generally established accounting principle:

Interest due = (number of days late/365) x (0.12) x (amount of unpaid balance)

This provision does not preclude RIDEM from seeking additional penalties according to Section D for failure to comply with the remaining provisions of this Agreement.

(v) All penalty payments shall be in the form of a <u>certified check, cashiers check, or money order</u>, payable to the *R.I. General Treasurer – Water and Air Protection Account*. All payments shall be delivered to:

### D. COMPLIANCE

- (1) <u>EFFECT OF COMPLIANCE</u> Compliance with and fulfillment of this Agreement shall be deemed to resolve all issues raised in the NOV.
- (2) <u>COMPLIANCE WITH OTHER APPLICABLE LAWS</u> Compliance with the terms of this Agreement does not relieve the Respondent of any obligation to comply with any other applicable laws or regulations administered by, through or for RIDEM or any other governmental entity.
- (3) <u>ADDITIONAL ENFORCEMENT ACTIONS</u> Upon a determination by the Director that there is a threat to the public health or the environment, or upon discovery of any new information, RIDEM reserves the right to take additional enforcement actions as provided by law or regulation, including, but not limited to, the issuance of "Immediate Compliance Orders" as authorized by R.I. Gen. Laws Section 42-17.1-2(21). This Agreement shall not restrict any right to hearing or other right available by statute or regulation that the Respondent may have regarding any new enforcement action commenced by RIDEM after the execution of this Agreement.
- (4) <u>FUTURE ACTIVITIES AND UNKNOWN CONDITIONS</u> This Agreement shall not operate to shield the Respondent from liability arising from future activities, as of the date of execution of this Agreement.
- (5) <u>SCOPE OF THE AGREEMENT</u> The scope of the Agreement is only violations alleged in the NOV.
- (6) <u>NOTICE AND COMMUNICATION</u> Communications regarding this Agreement shall be directed to:

(a) All communications regarding compliance with this Agreement shall be forwarded to the above-referenced addressees by certified mail.

- (7) <u>DEFERRAL</u> The Director may, for good cause shown, defer any of the compliance dates prescribed herein. Good cause for deferral of any compliance date shall be forwarded to RIDEM in writing at least fifteen days prior to the prescribed deadline.
- (8) AMENDMENT The Agreement may be amended by mutual agreement of the parties in writing.
- (9) EFFECTIVE DATE This Agreement shall be deemed entered as of the date of execution by all parties.
