# NOTICE OF VIOLATION

#### A. Introduction

Pursuant to Sections 42-17.1-2(21) and 42-17.6-3 of the Rhode Island General Laws, as amended, ("R.I. Gen. Laws") you are hereby notified that the Director of the Department of Environmental Management (the "Director" of "DEM") has reasonable grounds to believe that the above-named party ("Respondent") has violated certain statutes and/or administrative regulations under DEM's jurisdiction.

#### B. Facts

- (1) The facilities are located at 15 Wickham Road in the city of Newport ("Wickham Road Facility"), 541 Cooper Road in the town of Glocester ("Cooper Road Facility"), 8150-8166 Post Road in the town of North Kingstown ("Post Road Facility") and 121 Shannock Hill Road in the town of Richmond ("Shannock Hill Road Facility") (collectively, the "Facilities") and are operated by the Respondent.
- (2) The Facilities are (and have been) subject to DEM's Air Pollution Control ("APC") Regulations, including but not limited to, DEM's APC Regulation No. 9, entitled *Air Pollution Control Permits*.
- (3) On 13 April 2012, DEM received four permit applications from AT&T Services, Inc. on behalf of the Respondent. The applications included the following information:
  - (a) A 79 horsepower ("HP") diesel fired emergency engine/generator set was installed on 29 October 2008 at the Wickham Road Facility.
  - (b) A 79 HP diesel fired emergency engine/generator set was installed on 22 April 2011 at the Cooper Road Facility.
  - (c) A 79 HP diesel fired emergency engine/generator set was installed on 7 April 2011 at the Post Road Facility.
  - (d) A 79 HP diesel fired emergency engine/generator set was installed on 7 April 2011 at the Shannock Hill Road Facility.

# C. Violation

Based on the foregoing facts, the Director has reasonable grounds to believe that you have violated the following statutes and/or regulations:

- (1) **DEM's APC Regulation 9.2.1(a)** prohibiting the installation of any stationary source without obtaining a minor source permit from DEM for each installation described in APC Regulation 9.3.1.
- (2) **DEM's APC Regulation 9.3.1(b)** requiring a minor source permit for any emergency generator with an internal combustion engine of 50 HP or larger, and the date of initial startup is on or after November 15, 2007.

# D. <u>Penalty</u>

(1) Pursuant to R.I. Gen. Laws Section 42-17.6-2, the following administrative penalty, as more specifically described in the attached penalty summary and worksheets, is hereby ASSESSED, jointly and severally, against each named respondent:

# Four Thousand Dollars (\$4,000.00)

- (2) The proposed administrative penalty is calculated pursuant to the DEM's Rules and Regulations for Assessment of Administrative Penalties, as amended, and must be paid to the DEM within twenty (20) days of your receipt of this Notice of Violation ("NOV"). Payment shall be in the form of a certified check, cashiers check or money order made payable to the "General Treasury Water & Air Protection Program Account," and shall be forwarded to the DEM Office of Compliance and Inspection, 235 Promenade Street, Suite 220, Providence, Rhode Island 02908-5767.
- (3) Penalties assessed against Respondent in this NOV are penalties payable to and for the benefit of the State of Rhode Island and are not compensation for actual pecuniary loss.

# E. Right to Administrative Hearing

- (1) Pursuant to R.I. Gen. Laws Chapters 42-17.1, 42-17.6, 42-17.7 and 42-35, each named respondent is entitled to request a hearing before the DEM Administrative Adjudication Division regarding the allegations, orders and/or penalties set forth in Sections B through D above. All requests for hearing MUST:
  - (a) Be in writing. <u>See</u> R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.6-4(b);

(b) Be **RECEIVED** by DEM's Administrative Adjudication Division, at the following address, within twenty (20) days of your receipt of this NOV. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.7-9:

- (c) Indicate whether you deny the alleged violations and/or whether you believe that the administrative penalty is excessive. See R.I. Gen. Laws Section 42-17.6-4(b); AND
- (d) State clearly and concisely the specific issues which are in dispute, the facts in support thereof and the relief sought or involved, if any. See Rule 7.00(b) of the DEM Administrative Rules of Practice and Procedure for the Administrative Adjudication Division of Environmental Matters.
- (2) A copy of each request for hearing must also be forwarded to:

- (3) Each named respondent has the right to be represented by legal counsel at all administrative proceedings relating to this matter.
- (4) Each respondent must file a separate and timely request for an administrative hearing before DEM's Administrative Adjudication Division as to each violation alleged in the written NOV. If any respondent fails to request a hearing in the above-described time or manner with regard to any violation set forth herein, then this NOV shall automatically become a Final Compliance Order enforceable in Superior Court as to that respondent and/or violation and any associated administrative penalty proposed in the NOV shall be final as to that respondent. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and (v) and 42-17.6-4(b) and (c).
- (5) Failure to comply with this NOV may subject each respondent to additional civil and/or criminal penalties.
- (6) This NOV does not preclude the Director from taking any additional enforcement action nor does it preclude any other local, state, or federal governmental entities from initiating enforcement actions based on the acts or omissions described herein.
