## NOTICE OF VIOLATION

#### A. <u>Introduction</u>

Pursuant to Sections 42-17.1-2(21) and 42-17.6-3 of the Rhode Island General Laws, as amended, ("R.I. Gen. Laws") you are hereby notified that the Director of the Department of Environmental Management (the "Director" of "DEM") has reasonable grounds to believe that the above-named party ("Respondent") has violated certain statutes and/or administrative regulations under DEM's jurisdiction.

#### B. Facts

- (1) The subject facility is located at 498 Washington Street in the town of Coventry, Rhode Island (the "Facility") and is operated by the Respondent.
- (2) The Facility is a stationary source of air pollutants subject to the DEM's Air Pollution Control ("APC") Regulations.
- (3) On 14 May 2012, the DEM issued Approval No. 2166 to the Respondent which was revised on 21 December 2012 (the "Permit").
- (4) The Permit requires the Respondent to restrict the total quantity of volatile organic compounds ("VOCs") discharged to the atmosphere from the methyl chloride scrubber so as not to exceed 15 pounds per day.
- (5) On 1 February 2013, DEM received correspondence from the Respondent pertaining to emission exceedances that occurred at the Facility on 31 December 2012 and 1 January 2013. The Respondent reported that the Facility emitted 15.2 pounds and 17.7 pounds of VOCs, respectively, on those dates.

## C. <u>Violation</u>

Based on the foregoing facts, the Director has reasonable grounds to believe that you have violated the following statutes and/or regulations:

(1) **DEM's APC Regulation 9.6.8** – requiring any person who receives a permit to comply with all conditions in the permit.

#### D. Penalty

(1) Pursuant to R.I. Gen. Laws Section 42-17.6-2, the following administrative penalty, as more specifically described in the attached penalty summary and worksheets, is hereby ASSESSED, jointly and severally, against each named respondent:

## One Thousand Five Hundred Dollars (\$1,500.00)

- (2) The proposed administrative penalty is calculated pursuant to the DEM's *Rules* and *Regulations for Assessment of Administrative Penalties*, as amended, and must be paid to the DEM within thirty (30) days of your receipt of this Notice of Violation ("NOV"). Payment shall be in the form of a certified check, cashiers check or money order made payable to the "General Treasury Water & Air Protection Program Account," and shall be forwarded to the DEM Office of Compliance and Inspection, 235 Promenade Street, Suite 220, Providence, Rhode Island 02908-5767.
- (3) Penalties assessed against the Respondent in this NOV are penalties payable to and for the benefit of the State of Rhode Island and are not compensation for actual pecuniary loss.

## E. Right to Administrative Hearing

- (1) Pursuant to R.I. Gen. Laws Chapters 42-17.1, 42-17.6, 42-17.7 and 42-35, each named respondent is entitled to request a hearing before the DEM Administrative Adjudication Division regarding the allegations, orders and/or penalties set forth in Sections B through D above. All requests for hearing MUST:
  - (a) Be in writing. <u>See</u> R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.6-4(b);
  - (b) Be **RECEIVED** by DEM's Administrative Adjudication Division, at the following address, within thirty (30) days of your receipt of this NOV. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and 42-17.7-9:

- (c) Indicate whether you deny the alleged violations and/or whether you believe that the administrative penalty is excessive. See R.I. Gen. Laws Section 42-17.6-4(b); AND
- (d) State clearly and concisely the specific issues which are in dispute, the facts in support thereof and the relief sought or involved, if any. See Rule

7.00(b) of the DEM Administrative Rules of Practice and Procedure for the Administrative Adjudication Division of Environmental Matters.

(2) A copy of each request for hearing must also be forwarded to:

- (3) Each named respondent has the right to be represented by legal counsel at all administrative proceedings relating to this matter.
- (4) Each respondent must file a separate and timely request for an administrative hearing before DEM's Administrative Adjudication Division as to each violation alleged in the written NOV. If any respondent fails to request a hearing in the above-described time or manner with regard to any violation set forth herein, then this NOV shall automatically become a Final Compliance Order enforceable in Superior Court as to that respondent and/or violation and any associated administrative penalty proposed in the NOV shall be final as to that respondent. See R.I. Gen. Laws Sections 42-17.1-2(21)(i) and (v) and 42-17.6-4(b) and (c).
- (5) Failure to comply with this NOV may subject each respondent to additional civil and/or criminal penalties.
- (6) This NOV does not preclude the Director from taking any additional enforcement action nor does it preclude any other local, state, or federal governmental entities from initiating enforcement actions based on the acts or omissions described herein.

## **DEVIATION FROM THE STANDARD**

#### **FACTORS CONSIDERED:**

Taken from Section 10 (a) (2) of the DEM Rules and Regulations for Assessment of Administrative Penalties

- (A) The extent to which the act or failure to act was out of compliance: The Respondent failed to limit its VOC emissions to the restricted amount stated in the permit. The Respondent is a stationary source of air pollutants subject to state air pollution control regulations. Compliance with terms stated in the permit is of major importance to the regulatory program.
- (B) Environmental conditions: Considered, but not utilized for this calculation.
- (C) Amount of the pollutant: Respondent released a total of 2.5 pounds of VOCs during the 2 days of noncompliance.
- (D) **Toxicity or nature of the pollutant:** VOCs, after their release during certain atmospheric conditions in the presence of sunlight and other pollutants, contribute to the formation of ozone.
- (E) **Duration of the violation:** Records provided to DEM by the Respondent indicate that the noncompliance occurred on 2 consecutive days.
- (F) Areal extent of the violation: Considered, but not utilized for this calculation.

- (G) Whether the person took reasonable and appropriate steps to prevent and/or mitigate the noncompliance: The Respondent failed to take reasonable and appropriate steps to prevent the noncompliance. The Respondent mitigated the violation by informing DEM that it identified the root cause of the emission exceedances and had implemented appropriate administrative controls to prevent recurrence prior to issuance of a notice of alleged violations by DEM to the Respondent on 5 August 2013.
- (H) Whether the person has previously failed to comply with any regulations, order, statute, license, permit or approval issued or adopted by the Department, or any law which the Department has the authority or responsibility to enforce: The Respondent was issued a NOV and assessed an administrative penalty in 2011 for a matter unrelated to the violation that is the subject of this NOV. Respondent paid an administrative penalty.
- (I) The degree of willfulness or negligence, including but not limited to, how much control the violator had over the occurrence of the violation and whether the violation was foreseeable: The Respondent had complete control over the violation since the Respondent is the operator of the Facility. The violation was foreseeable by the Respondent.
- (J) Any other factor(s) that may be relevant in determining the amount of a penalty: The violations were self-reported by the Respondent.
