ADMINISTRATIVE PROCESSING

Upon receipt of this form and required fee, your application will be reviewed for completeness and compliance with Rule 13.3 of the OWTS Rules. Upon completion of this review, you will receive written acknowledgement of the disposition of the renewal of your license, in the form of a new license or a notice of expiration, citing the reason for the expiration. Any valid license, for which a renewal application is submitted on or before December 31, 2017, shall be considered valid unless otherwise indicated in the disposition acknowledgement.

NOTE that there will be **NO GRACE PERIOD**. If as of January 2, 2018, an application for renewal of an Installer License is not received by this office the license will be expired. Forms that are post-marked or received by drop-off at RIDEM after December 31, 2017 will be late renewals and a **late fee** will be due.
