



Block Island State Land (Black Rock/Rodman’s Hollow) Hunting Lottery Application 2021-2022 Season



Group Application

1. Applications must be legibly filled in completely and returned along with a stamped, self-addressed envelope to: **Block Island State Land Lottery, Division of Fish and Wildlife, 277 Great Neck Road, West Kingston, RI 02892.**
2. All applications must be postmarked by **September 15th** to be eligible for the Block Island State Land Hunt.
3. Groups shall only submit **one** application.
 - a. Group sizes range from 2 to 6 hunters.
4. Place a 1 alongside your groups first choice, 2 for second choice, 3 for third choice and 4 for fourth choice.
5. Selecting 4 choices signifies your group is willing to be placed in any open segment.
 - a. If you do not select all 4 choices and are not selected for one of your priority choices, your group will not be selected for an open segment.
6. After the lottery is completed, individual members of the group have the option to hunt if the group is not selected by marking the box under each hunter.
7. Participants will be selected by lottery. All decisions are final.

BLOCK ISLAND STATE LAND HUNT LOTTERY CONDITIONS

1. Deer Hunting only allowed; no hunting for any other species and/or no other activities permitted. Hunters will follow deer hunting seasons and regulations for Zone 4 and any additional requirements of the permit.
2. The only state land parcels included in this hunt are the Black Rock/Rodman’s Hollow state lands.
3. Hunters are required to have the written permit and a photo ID in their possession at all times while hunting and are required to fill out a daily hunting record log for the entire season. The hunting permit and daily hunting record must be returned to RIDEM at the conclusion of the season (by March 1st). **Failure to submit hunting records to the Division of Fish & Wildlife will result in your disqualification from the next year’s hunt.**
4. Applications to hunt Block Island State Lands are available online (www.dem.ri.gov), by emailing dem.dfw@dem.ri.gov, or by sending a self-addressed stamped envelope to the Division of Fish & Wildlife.
5. Any hunter failing to comply with any and all provision of this cooperative hunting season will be terminated from the program and will lose hunting privileges for future hunts.
