Osprey Nesting Season

This was another successful season for the Rhode Island ospreys. The number of active nests decreased slightly from last year's 108 to 104 nests while the number of young decreased from 151 to 145. While some locations were not as productive, the season overall was very successful.

Several new sites were discovered, on top of water, light and cellular phone towers. This continues to be problematic, as it is very difficult to lure ospreys to alternate sites that can't compete with the 80-199 foot height of these structures. We continue to work closely with towns and utilities to alleviate electrical or human health and safety concerns. We also continue to monitor cell towers as osprey advocates to alleviate conflicts.

Table 1 of the newsletter contains the activity of all known nests. If we have inadvertently incorrectly reported any activity, please do not hesitate to contact us at the numbers above.

Osprey mortalities and incidents

We were notified of several osprey mortalities this season. A young osprey at North Kingstown's Ryan Park nest died. Additionally, one youngster in Apponaug was electrocuted and another died at the nest at Napatree Point. A nest in the Tongue Marshes in Barrington fell in early July with young in the nest which did not survive. Also, one of the young in the nest at the Quonset Golf Course in North Kingstown died as a result of multiple broken bones. Vivian Maxson, of the Born to be Wild Nature Center in Bradford, was able to successfully rehabilitate and release a young osprey.

NEW POLES AND PLATFORMS

The Division would like to thank the Audubon Society for offering to erect a nest pole in the salt marsh adjacent to Hazard Road in Newport. The Audubon Society will also be making site visits to find potential nest pole sites.

National Grid also unveiled three new nest poles in the Town Pond area in the Portsmouth area. The nests were not used this season, but hopefully will be used in the future.

US Fish & Wildlife is erecting a new pole in Long Cove in the Narragansett Area.

Anyone who is interested in putting up new poles may contact the Division for guidance. We will assist and give advice for best placement and specifications of these poles. As in the past, the appropriate permits need to be acquired from CRMC for pole placement within coastal or freshwater wetlands.
