INSTRUCTIONS

1. APPLICATIONS MUST BE FILLED IN COMPLETELY AND RETURNED ALONG WITH A STAMPED SELF-ADDRESSED ENVELOPE TO: **PWS COOP, DIVISION OF FISH AND WILDLIFE, 277 GREAT NECK ROAD, WEST KINGSTON, RI 02892**
2. DUPLICATE, ILLEGIBLE, INCORRECT, OR INCOMPLETE FORMS WILL BE REJECTED. PARTICIPANTS WILL BE SELECTED BY LOTTERY, 150 HUNTERS WILL BE SELECTED. ALL DECISIONS ARE FINAL.
3. ALL APPLICATIONS MUST BE POSTMARKED BY AUGUST 15, 2011 TO BE ELIGIBLE FOR THE PWS HUNT.
4. APPLICANTS CERTIFY THAT THEY WILL ABIDE BY ALL CONDITIONS AND REQUIREMENTS OF THE PWS COOP HUNT AND FAILURE TO DO SO WILL RESULT IN THE REVOCATION OF THE PWSB HUNTING PERMIT.

PWSB - Tunk Hill Hunting Coop Conditions

1. **Deer Hunting only allowed.** Hunters will follow deer hunting seasons and regulations for Zone 1 and any additional requirements of the PSW Coop permit
2. Hunters must abide by all other State deer hunting regulations and additional requirements of this permit. This hunt may be suspended at any time due to conditions at the exclusive determination of the DEM and the Providence Water Supply Board.
3. Hunters will be required to attend a pre-hunt meeting (to obtain maps and specific instructions) and must possess a hunting license and a minimum of two valid antlerless deer hunting tags at that meeting.
4. Hunters are required to have the written permit and a photo ID in their possession at all times while hunting and are required to fill out a daily hunting record log for the entire season. The hunting permit and daily hunting record must be returned to DEM at the conclusion of the season (by February 15, 2012).
5. Construction of permanent tree stands is prohibited; however, the use climbing, ladder or hang on stands that do not damage trees are allowed. Tree stands must be removed immediately at the conclusion of the season.
6. No hunting for any other species and/or no other activities are permitted.
7. Applications to hunt the cooperative are available online (www.dem.ri.gov) or by sending a self addressed envelope from the Great Swamp Field Headquarters, 277 Great Neck Road, West Kingston, RI 02892. Applications must be postmarked by August 15, 2011.
8. Failure of any hunter to comply with any and all provisions of this cooperative hunting season will be terminated from the program and will lose hunting privileges for future hunts.
