\* The harvest or possession of Winter Flounder is **PROHIBITED** in Point Judith Pond, the Harbor of Refuge and in Narragansett Bay, north of the Colregs line. Vessels with a Federal Northeast Multispecies permit may NOT possess or land SNE/MA winter flounder.

### RI Recreational Saltwater License

Available online at: [www.saltwater.ri.gov](http://www.saltwater.ri.gov)

Also available from certain bait & tackle shops.

- **Fees:**
  - \$7.00 RI residents (annually)
  - \$10.00 Non-residents (annually)
  - \$5.00 7-Day license
- **Applies** in all RI waters, all offshore federal waters, and MA, CT and NY waters
- **Free** licenses for RI residents over 65; or active military stationed in RI
- **No license** required for children under 16, blind or disabled persons as well as anglers on party & charter boats.

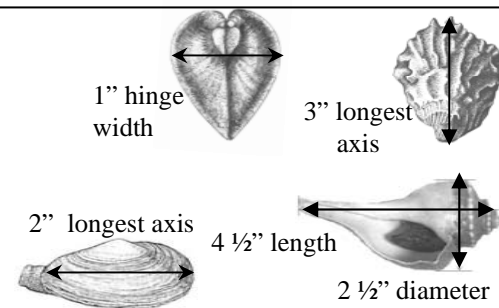

### Shellfish:

#### MINIMUM SIZES

- Quahaug = 1" hinge width
- Soft-Shell Clam = 2" longest axis
- Oyster = 3" longest axis
- Scallop = No seed possession
- Surf Clam = 5" longest axis
- Whelk (Conch) = 2 1/2" diameter or 4 1/2" length



### DAILY POSSESSION LIMITS FOR QUAHAUGS, SOFT-SHELLED CLAMS, SURF CLAMS, MUSSELS, AND OYSTERS (BAY SCALLOPS EXCLUDED) IN:

#### Shellfish Management Areas

#### Non-Management Areas

**Resident (no sale)=**

1 peck each/day/person

**Commercial =**

3 bushels each/day/person

**Licensed Non-resident (no sale) =**

1/2 peck each/day/person

**Resident (no sale) =**

1/2 bushel each/day/person

**Commercial =**

12 bushels each/day/person

**Licensed Non-resident (no sale) =**

1 peck each/day/person

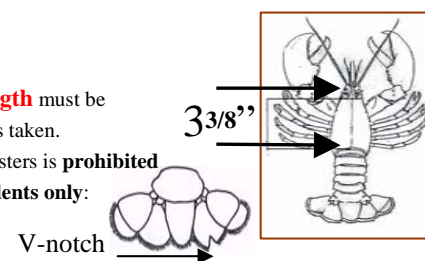
#### Conimicut Point Shellfish Management Area

Resident & Non-residents follow possession limits for Management Areas

**Commercial = 3 bushels day/person for Soft-Shell Clams**

### Lobsters:

- All lobsters must be measured **IMMEDIATELY**
- Lobsters measuring less than **3 3/8" carapace length** must be returned to the water immediately from which it was taken.
- The **POSSESSION** of egg-bearing or v-notched lobsters is **prohibited**
- Non-Commercial possession limit for **licensed residents only**:  
**Pots** – 5/pots/recreational license  
**Divers** – 8 lobsters/day



### Blue Crabs:

- All Blue Crabs measuring less than **5" spike to spike** shall be returned to the water immediately.
- No person shall possess, take, or attempt to take more than 25 blue crabs from any of the waters in this state except when taking by crab net, dip net, scoop net, hand line or trot line.
- Harvesting of blue crabs is **restricted to residents of the state** between sunrise and sunset.
- The **POSSESSION** of egg-bearing crabs is **prohibited**.

Measured from tip of spike to tip of spike.
