
**Youth Pheasant Hunt Weekend – License and tags required

Pheasant stocking locations will be Great Swamp Management Area in West Kingston; Durfee Hill Management Area in Glocester; and Eight Rod Farm in Tiverton

The training session is not mandatory to participate in the hunt but will help prepare students for a successful hunt. Topics to include:

- Proper gear and clothing
- Rules and regulations for Pheasant hunting
- Pheasant habitat and behavior with live pheasants on hand for demonstration and discussion
- Gun safety in the field
- Clay target shooting - We will provide safety gear and 12 & 20 gauge ammo. You may bring your own shotgun or borrow one of ours.
- Introduction to hunting dogs
- Specific information about Youth Pheasant Hunting Weekend
- **The Federated RI Sportsman's Club** members will provide lunch to all participants.
