*** What is needed to register a outboard motor

- Notarized Bill of Sale from private sale or bill of sale on Dealer's letterhead (new or used)
- 7% Sales Tax Receipt (on new or used motors purchased only from Retailer/Dealer, if purchased from private party, tax exempt. Please note, all taxes must be paid prior to registration). If motor is a gift, must provide documentation that donor had motor registered or proof of tax payment by donor must be provided.
